UniCredit Bank and CDP signed a 40 mln euro credit line agreement intended for small and medium-sized enterprises in Serbia

Belgrade, February 1, 2024 – During the ceremonial opening of the CDP (Cassa Depositi e Prestiti) office in Belgrade, UniCredit Bank signed with this renowned institution an Agreement on the financing of local small and medium-sized enterprises, as part of the Investment Framework for the Western Balkans promoted by the European Union. Funds allocated through this Program will provide financing at favorable interest rates to local companies that operate in sectors with a high ESG impact, i.e. have a positive effect on the wider environment, society and business. In this way, the initiative will enable the creation of new jobs in Serbia and contribute to the achievement of the five goals of sustainable development of the United Nations.

Thanks to the funds from the new credit line, UniCredit Bank will be able to offer more favorable financing conditions to clients. Funds from this line in the total amount of 40 million euros, which will be placed, will enable the bank to provide additional support to Serbian companies that are committed to improving gender equality, that operate in less developed areas, operate in the health and education sectors, improve sustainable agriculture and processing, as well as acceptance and adaptation to climate change.
